 "Customer" means the Customer or any person acting on behalf of and with the authority of the Customer.

 "Guarantor" means that person (or persons), or entity who has agreed to be liable for the debts of the Customer on a principal debtor basis.

 "Goods" means goods supplied by Homestyle Bakeries to the Customer (and where the context so permits shall include any supply of Services as hereinafter defined).

 "Services" means all services supplied by Homestyle Bakeries to the Customer and include any advice or recommendations (and where the context so permits shall include any supply of Goods as defined supra).

 "Price" means the cost of the Goods supplied to the Customer from time to time as determined by clause 4 of these terms and conditions and as. 1.6

- Acceptance and Application of Terms and Conditions
 The receipt by Homestyle Bakeries from the Customer of the first order for the supply of Goods shall constitute acceptance by the Customer of these terms and conditions.
- with the control of the customer of these terms and conditions. Where more than one Customer have together placed an order for Goods, the Customers are jointly and severally bound by these terms and conditions. 2.2

 Nothing in these terms and conditions obliges the Customer to place any order with Homestyle Bakeries for the supply of Goods or for Homestyle Bakeries to accept any order for Goods placed by the Customer. None of Homestyle Bakeries' agents or representatives are authorised to make any representations, statements, conditions or agreements not expressed by a director of Homestyle Bakeries in writing nor is Homestyle Bakeries bound by any such unauthorised statements.

 The Customer must give Homestyle Bakeries not less than fourteen (14) days prior written notice of any proposed change in the Customer's name and/or any other change in the Customer's details (including but not limited to, changes in the Customer's address, facsimile number, or business practice). 26

Goods
The Goods will be as described on the invoices, quotation, work authorisation or any other work commencement forms as provided by Homestyle Bakeries to the Customer.

Price And Payment

- At Homestyle Bakeries' sole discretion, the Price shall be either;

 Time for payment for the Goods shall be of the essence and will be stated on the invoice, quotation or any other order forms. If no time is stated, then payment shall be on delivery of the Goods.

 If payment is required on or prior to delivery of the Goods, Homestyle Bakeries may withhold delivery of the Goods until the Customer has paid for them in full.

 At Homestyle Bakeries' sole discretion for approved Customers, payment will be due either seven (7) or thirty (30) days following the date of the invoice or as otherwise agreed in writing between Homestyle Bakeries and that Customer.

 The Prices are exclusive of any GST and other taxes and duties which may be applicable, except to the extent 4.7
- that such taxes are expressly included in any quotation given by Homestyle Bakeries.

 Homestyle Bakeries may change all or any of the Prices on the current Price List at any time by giving the

 Customer at least 30 days notice of the change in Price. 4.8

- Delivery Of Goods / Services
 Unless the Customer directs otherwise, delivery of the Goods shall be made to the Customer's address. The Customer shall make all arrangements necessary to take delivery of the Goods whenever they are tendered for delivery or failing that, delivery of the Goods shall be made to the Customer at Homestyle Bakeries

 Delivery of the Goods to a carrier, whether nominated by the Customer or failing such nomination, to a carrier nominated at the discretion of Homestyle Bakeries for the purpose of delivery to the Customer, is deemed to be a delivery of the Goods to the Customer.

 The costs of carriage and any insurance which the Customer reasonably directs Homestyle Bakeries to incur, shall be reimbursed by the Customer (without any set-off or other withholding whatever) and shall be due on the date for payment of the Price. If the is nominated by the Customer, then that carrier is be deemed to be the Customer's agent.

 Delivery of the Goods to a third party nominated by the Customer is deemed to be delivery to the Customer for the purposes of these terms and conditions.

 The Customer shall take delivery of the Goods tendered notwithstanding that the quantity so delivered shall be either greater or less than the quantity purchased provided that:

- 5.6 The failure of Homestyle Bakeries to deliver any Goods shall not entitle the Customer to treat these terms and conditions as repudiated.
- Homestyle Bakeries shall not be liable for any loss or damage whatsoever suffered by the Customer due to failure by Homestyle Bakeries to deliver the Goods (or any of them) promptly or at all. 5.7

- 6.1 Regardless of whether Homestyle Bakeries retains title in the Goods , all risk for the Goods passes to the Customer on delivery
- Regardless of whether Homestyle Bakeries retains title in the Goods , all risk for the Goods passes to the Customer on delivery.

 If any of the Goods are damaged or destroyed prior to title in them passing to the Customer, Homestyle Bakeries is entitled, without prejudice to any of its other rights or remedies under these terms and conditions of trade (including the right to receive payment of the Price for the Goods), to receive all insurance proceeds payable for the Goods. This applies whether or not the Price has become payable under these terms and conditions. The production of these terms and conditions by Homestyle Bakeries is sufficient evidence of Homestyle Bakeries' rights to receive the insurance proceeds without the need for any person dealing with Homestyle Bakeries to make further enquiries. 6.2

Customer's Disclaimer

The Customer hereby disclaims any right to rescind, or cancel these terms and conditions or to sue for damages or to claim restitution arising out of any misrepresentation made to the Customer by any servant or agent of Homestyle Bakeries and the Customer acknowledges that it buys the Goods relying solely upon its own skill and judgement.

- Defects / Returns
 The Customer shall inspect the Goods on delivery and must within one (1) day of delivery notify Homestyle Bakeries of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Customer shall afford Homestyle Bakeries an opportunity to inspect the Goods within a reasonable time following delivery if the Customer believes the Goods are defective in any way. If the Customer shall fail to comply with these provisions, the Goods shall be conclusively presumed to be delivered in accordance with these terms and conditions and free from any defect or damage. For defective Goods which Homestyle Bakeries has agreed in writing that the Customer is entitled to reject, Homestyle Bakeries' liability is limited to either (at Homestyle Bakeries discretion) replacing the Goods or refunding the Price for those Goods.

- Unpaid Homestyle Bakeries Rights To Dispose Of Goods
 In the event that:

 (a) Homestyle Bakeries retains or regains possession or control of the Goods; and
 (b) payment of the Price for those Goods is due to Homestyle Bakeries; and
 (c) Homestyle Bakeries has made a demand in writing of the Customer for payment of the Price in terms of

Homestyle Bakeries may cancel these terms and conditions and/or cancel the delivery of Goods at any time before the Goods are delivered by giving written notice to the Customer. Homestyle Bakeries shall not be liable for any loss or damage whatever arising from such cancellation.

- Default & Consequences Of Default
 Interest on overdue invoices shall accrue from the date when payment becomes due daily until the date of
 payment at a rate of 10% compounding per calendar month and shall accrue at such a rate after as well as

 If the Customer defaults in payment of any invoice when due, the Customer indemnifies Homestyle Bakeries

- Homestyle Bakeries agent's costs of collection, including any costs of engaging a debt collection agency to recover any amounts owing to Homestyle Bakeries. Bakeries may have if at any time the Customer is in breach of any obligation (including those relating to payment) of these terms and conditions, Homestyle Bakeries may suspend or terminate the supply of Goods to the Customer and any of its other obligations under the terms and conditions. Homestyle Bakeries will not be liable to the Customer for any loss or damage the Customer suffers because Homestyle Bakeries exercises its rights under this clause.  Title in all Goods shall not pass until:

 (a) The Customer has paid all amounts owing for those particular Goods, and

 (b) The Customer has met all other obligations due by the Customer to Homestyle Bakeries in respect of all contracts between Homestyle Bakeries and the Customer, and that where practicable the Goods shall be kept separate until Homestyle Bakeries shall have received payment and all other obligations of the Customer are met.

 Receipt by Homestyle Bakeries of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised and until then Homestyle Bakeries

 may enter upon and into land and premises owned, occupied or used by the Customer, or any premises
 as the invitee of the Customer, where the Goods are situated and take possession of the Goods.

 The Customer is only a bailee of the Goods and until such time as Homestyle Bakeries has received
 payment in full for the Goods then the Customer shall hold any proceeds from the sale or disposal of
 the Goods on trust for Homestyle Bakeries.

 The Customer shall not deal with the money of Homestyle Bakeries in any way that may be adverse to
 Homestyle Bakeries.

 The Customer shall not charge the Goods in any way nor grant nor otherwise give any interest in the
 Goods while they remain the property of Homestyle Bakeries.

 Homestyle Bakeries can issue proceedings to recover the Price of the Goods sold notwithstanding that
 ownership of the Goods may not have passed to the Customer.

 Until such time that ownership in the Goods passes to the Customer, if the Goods are so converted, the
